- 5. If this agreement is reviewed or superseded by national contracts during the period covered, then this agreement may need to be terminated and the activity transitioned to the national contract. Where national contract refers to those let by bodies on behalf of the NHS, for example, but not limited to, NHS Supply Chain (SCCL Ltd), Crown Commercial Services (CCS) or other Category Tower bodies.
