It has been another very challenging year for everyone and these challenges look set to continue into 2023. We wanted to tell you what we have been up to this year and provide information regarding a change to your pricing from December 2022.

At Biffa we are continuing to develop innovative new ways of operating, make improvements to the customer experience and drive a more sustainable future for the waste management industry.

**Digital account management** - In 2022 we launched myBiffa. This new digital portal gives you more flexibility and control to manage your service online whenever you choose, including viewing your invoices and booking additional services. Thank you for being a regular user of this new portal, we will bring you new developments and features over the coming months.

**Leading Sustainability** – We continue to make progress on our ambitious sustainability targets, with a 28% reduction in our CO2 emissions and a 140% increase in our plastic recycling capacity since 2019. Working across our organisation, and closely with our customers and supply chains, Biffa has been able to certify the rPET produced at our Seaham recycling facility as suitable for food grade. This fantastic achievement enables a comprehensive closed recycling process where the PET bottles recovered through our Dry Mixed Recycling collections, and sorted at our Recycling Facilities, can be returned back into food grade rPET by our Polymers teams for remanufacturing into PET bottles. **UK's first Deposit Return Scheme (DRS)** – Biffa has been awarded the logistics contract for the first DRS, which is starting in Scotland before coming to the broader UK. Deposit return schemes are used across the world as a way of encouraging more people to recycle drinks containers. A small deposit is charged for the bottle or can, that the consumer can then get back when they return it to a collection point to be recycled. This aligns with our sustainability strategy, around building a circular economy and tackling climate change. Through this scheme we will increase recycling and help to reduce carbon emissions, which will have a positive impact on the environment.

**Supporting communities** – A 10<sup>th</sup> Community Shop was opened this year in Bradford, providing members with vital access to deeply discounted food. Managed by one of our divisions - the Company Shop Group - the award-winning Community Shop not only helps to reduce waste, it also provides life-changing learning and development programmes for local communities.
