Please note: The Veterinary version includes both standard patient leads (2520000) as well as the croc clip version (2520020).

The Microstim DB3 is now only available to purchase for use in Veterinary environments. The product is no longer CE marked and is therefore not certified for human clinical use within the EU.

The Microstim DB3 was discontinued as a medical product on the 17th May 2019. The reason being is that it is not feasible to certify this legacy product to meet the requirements of the European Union Medical Device Regulation (MDR).

The decision to discontinue the Microstim DB3 does not affect any devices already supplied, which were fully compliant with CE regulatory requirements that were in place when the devices were sold. Any devices currently in service bear a valid CE mark and there is no need to withdraw the units from use.

We will be looking at purchasing two TOF3D initially and possibly two more within months.
