Unfortunately, the price quoted on your order is incorrect. The current price breaks for part number 0110403 (MAX-3 Oxygen Sensor) are as follows:

1 unit - £80.00

2 units - £76.00

3-10 units - £72.00

11+ units - £68.00

Unfortunately, we do not currently have these sensors available in stock, and furthermore, the above prices are only valid until 6th February, where they are then due to increase. I would expect the lead time for the MAX-3 sensor to be approximately 6 weeks.

An alternative sensor, which is available in stock and at a lower cost would be the R-48V (part number 0110048). The price breaks are as follows:
