Hi Tim and Tony,

Just to let you know, we now have the Ultramax O2 analysers in stock in sufficient quantity to meet your requirement in full.

I'm sure we all need to do some catching up after the Christmas period but in summary, the deal that we discussed was a part credit / part pro-forma split as follows:

- 15-off @ £412.00+VAT = £6,180+VAT on 30-day terms (Total £6,192+VAT including delivery)
- 25-off @ £478.40+VAT = £11,960+VAT on proforma (Total £11,972+VAT including delivery)

In order to release the order, we would require pro-forma payment of £11,972+VAT up front, with the remaining balance of £6,192+VAT on 30-days from the date of invoice.

Please note: the carriage that has been applied is standard shipping on UPS '*Carriage Paid To*' delivery terms (CPT - Incoterms 2020). This means that **the shipment is not covered by insurance for loss or damage once it leaves Viamed's premises and the risk is assumed by the purchaser**, or the purchaser may arrange their own insurance to cover it.

Given the value of the order, if you don't have your own insurance in place and would like to upgrade the delivery to '*Carriage and Insurance Paid To*' (CIP - Incoterms 2020), we can do this at an additional insurance premium of 1% of total goods value. If you want to take this option, please advise and I will have the order and proforma revised.

If you are in a position to make the proforma payment, we should be able to get these out after just a couple of days of QA testing.

I would welcome the chance for a catch-up on this when convenient and look forward to hearing from you.

We have looked into this and unfortunately, we simply cannot offer the full 40 at the old distributor price of £412.00 as the price to us has increased significantly and this would result in selling at a loss.

We hope to be able to get the further 25 units to make up the full order of 40 units before the end of the month for delivery the first week in January (or before if the logistics allow).

I've spoken to my Commercial Director and the best that we can do in order to facilitate a part-credit, part-proforma offer is as follows:

- 15-off @ £412.00+VAT = £6,180+VAT on 30-day terms

Hi Tony,

That's great, I'm glad that we can get moving on this, it sounds like a great ongoing opportunity for both companies.

Referring to my email on 25th November, as we agreed to hold the price at £412.00+VAT until the year end for the existing stock, that would actually mean **14 units on this first order** will still be within your £6k credit limit if you want them.

We will need to re-stock after this, so future orders would be at a Distributor price (qty 5+) of £478.40+VAT, which then equates to 12 units per order.

If you can settle the invoice within 30 days, I will push for an increase on your credit limit with the aim of getting the order size up to 15 units if that is a better number for you.

Thanks for the update. The price did unfortunately have to go up quite a bit after we spoke in October due to price increases from the manufacturer, the current pricing is as follows:

P/n: 0111265 - UltraMaxO2 Oxygen Analyser  
Unit price: £598.00+VAT  
**Distributor price (qty 5+): £478.40+VAT**  
Carriage: £12.00+VAT per shipment

I appreciate that this is a hefty increase, but it is completely out of our control. If it will soften the blow, we have 15 units in stock that were purchased in before Maxtec increased the price, I don't expect these to last for long but if you can get the order from your customer before the end of the year, *and if we still have them in stock*, I could get these to you at the previous distributor price of £412.00+VAT. Anything after that means we are paying a higher price ourselves so it will have to be at the higher selling price.

I know that this is out of your hands at the moment, I've been there myself waiting on paperwork to clear and tenders to come to fruition etc, so I will leave it with you for now and wish you luck in gaining the orders.
