Hi Amy,

Thank you for your order. The order breaks down as follows:

- 25x 0111265 UltraMax O2 Analyser (@ £478.40+VAT each): £11,960.00+VAT
- Shipping Insurance (optional\*): £119.60+VAT
- Carriage: £12.00+VAT

\*Please note: standard shipping is via UPS on 'Carriage Paid To' delivery terms (CPT - Incoterms 2020). This means that **the shipment is not covered by insurance for loss or damage once it leaves Viamed's premises and the risk is assumed by the purchaser**, or the purchaser may arrange their own insurance to cover it.

Given the value of the order, if you don't have your own insurance in place and would like to upgrade the delivery to 'Carriage and Insurance Paid To' (CIP - Incoterms 2020), we can do this at an additional insurance premium of 1% of total goods value. If you want to take this option, please advise.

I have spoken with the Finance Director and Commercial Director, who have advised that the maximum credit limit offered is £6K+VAT, which equates to 12 units, so we need to look at the other settlement options as before.

We currently have 10 units available in stock, so one option is to split your order into 2 separate orders for 10 units and 15 units. We can ship 10 now on credit terms, then when the account is cleared, ship the second order. That second order would allow 12 on credit terms with just 3 left to settle by proforma.

Alternatively, we could process this as 12 units on credit when the rest of the stock arrives and 13 on proforma.

I apologise for the financial wrangling, but due to some recent experiences with debtors going insolvent, £6k on terms of 30 days from invoice is the maximum credit limit that Viamed can extend.

I look forward to hearing from you to see how we can work together to process this.
