Thank you for your order. Please be aware - part number 4310003 has now been discontinued and replaced with part number 4310009 - the product is exactly the same, but now comes with Bluepoint branding, instead of Viamed.

Also, part number 0110024 (R-24MED Oxygen Sensor) is not currently in stock and there would be a lead time of approximately 3-4 weeks.
