This is regarding your order, 525133.

We have recently updated our insurance policy and procedure. Viamed product prices are supplied as EXW (Ex-Works) Incoterms 2020. We now offer optional shipping insurance to distributors placing orders. Viamed standard shipping service is via UPS' standard CPT (Carriage Paid To) delivery Incoterms 2020. This means that the shipment is not covered by insurance for loss or damage once it leaves Viamed premises over the shipment value of £60.

As part of our distributor review we are now required to have written confirmation whether the goods will be covered by your own insurance or if you wish for insurance to be added to your orders. Upgrading your deliveries to CIP (Carriage and Insurance Paid) by adding an additional insurance premium at 1% of total goods value (ex-vat, minimum charge of €11.50) means that any loss or damage during transit would be covered.

Please let me know if you require insurance so I can proceed with the order.
