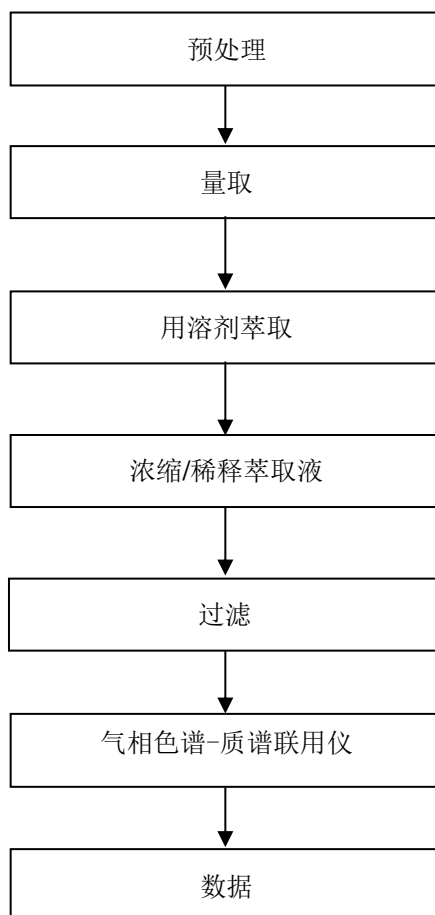

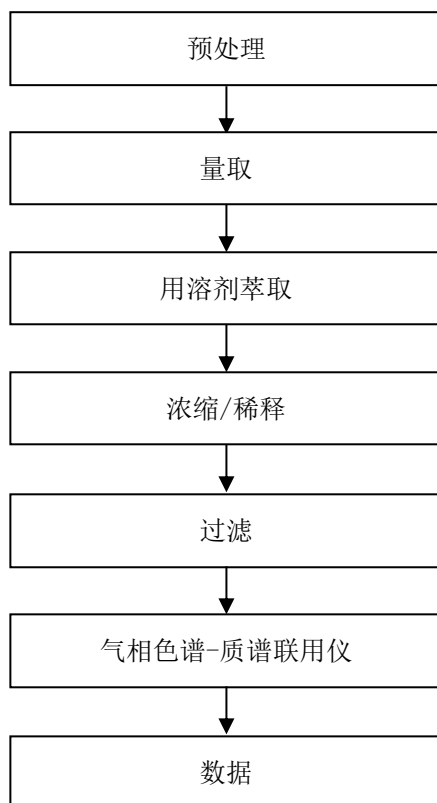

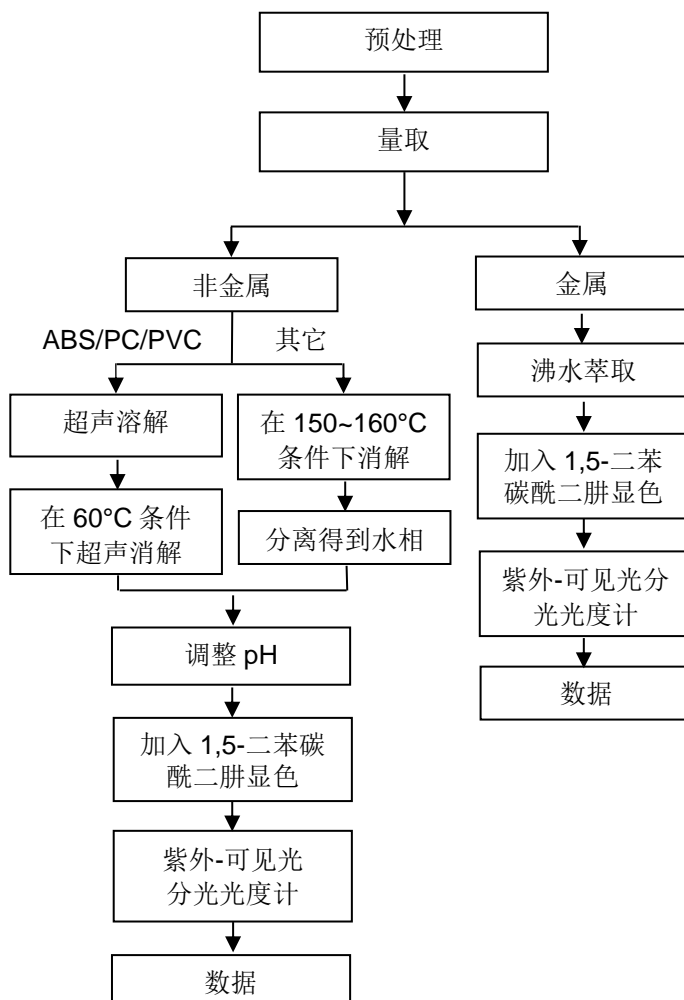
PBBs/PBDEs 检测流程图



Phthalates 检测流程图

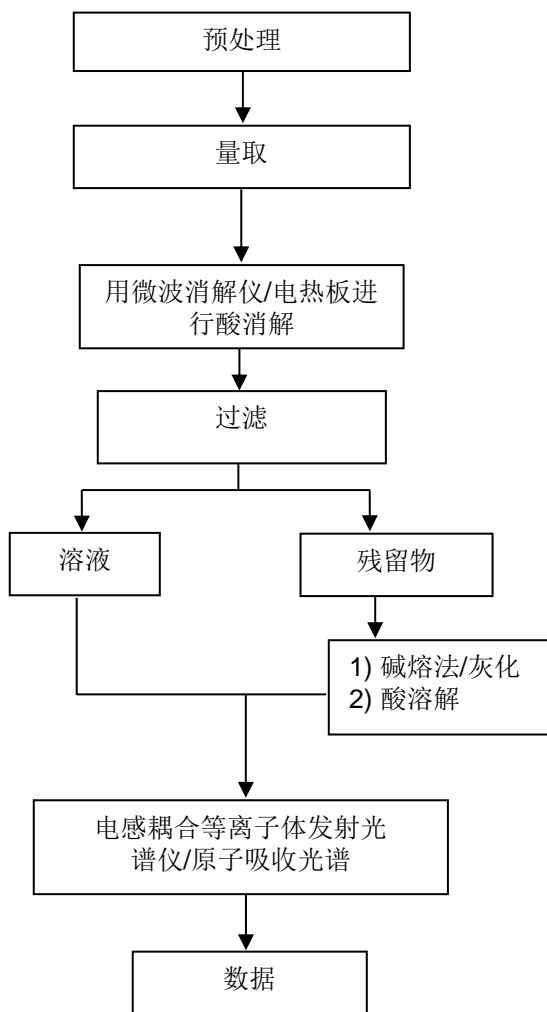


六价铬检测流程图
