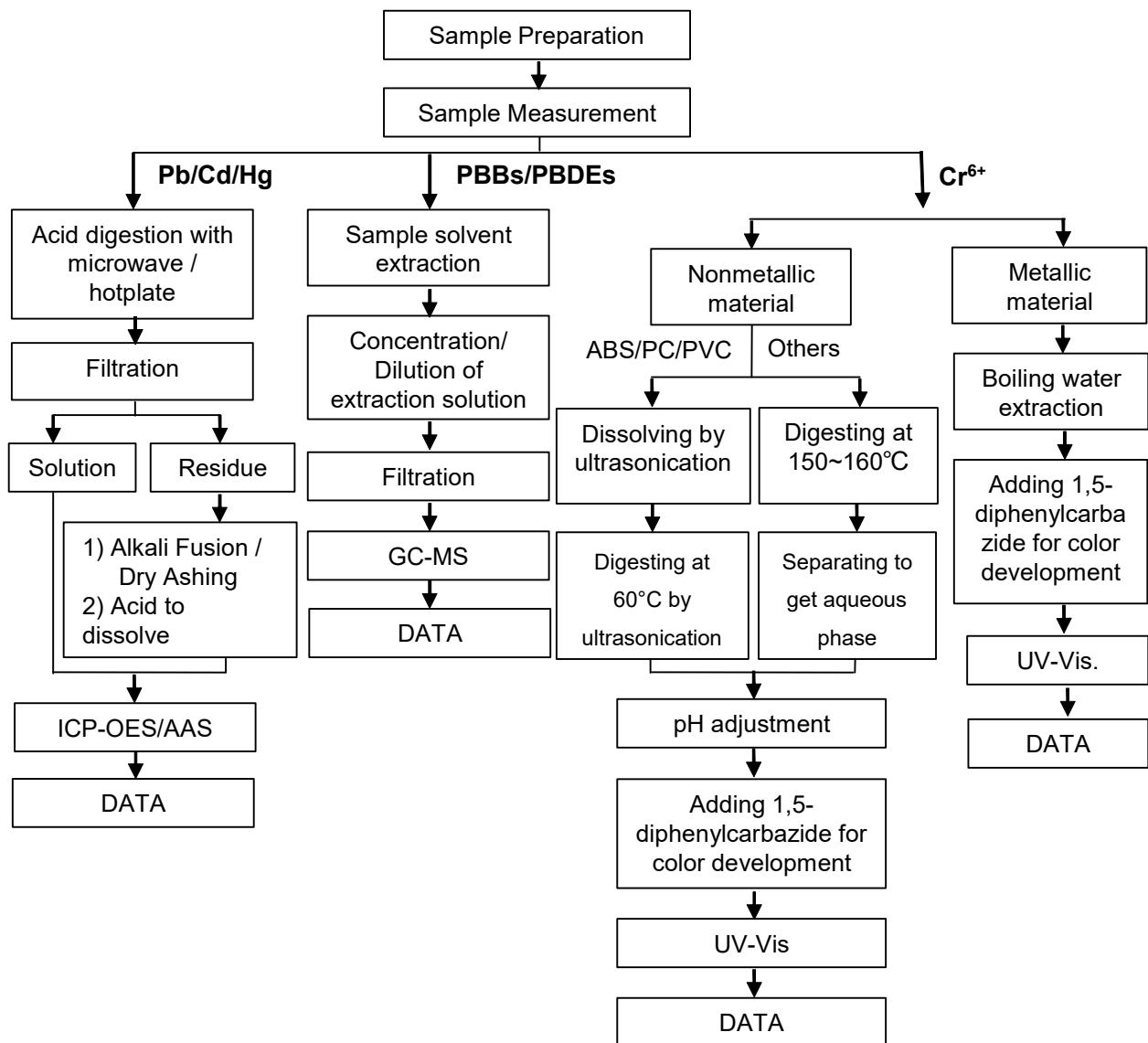

(Cr⁶⁺ and PBBs/PBDEs test method excluded).

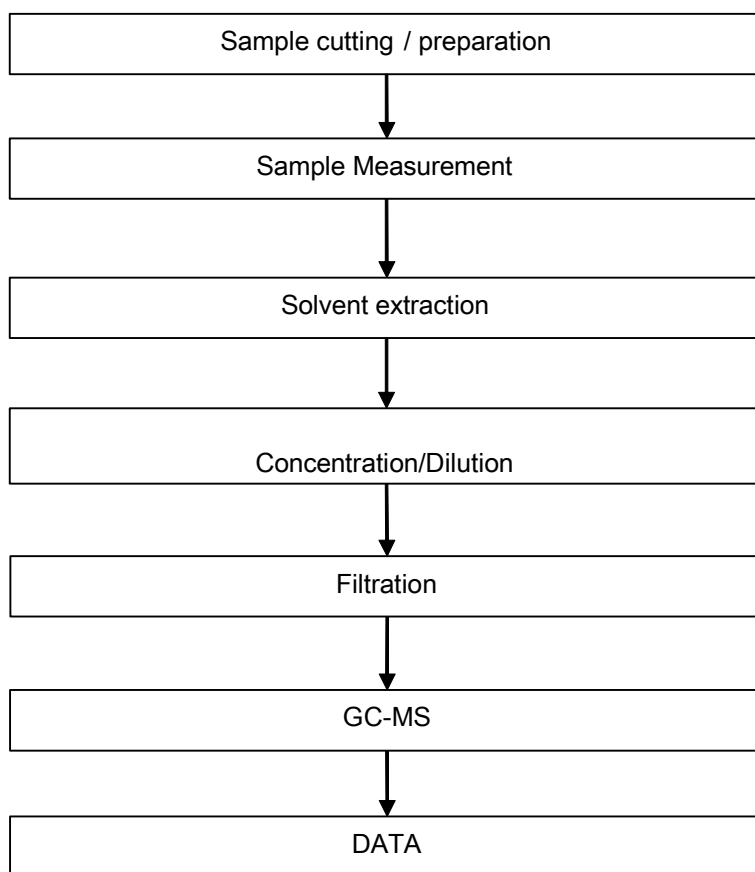

Phthalates Testing Flow Chart



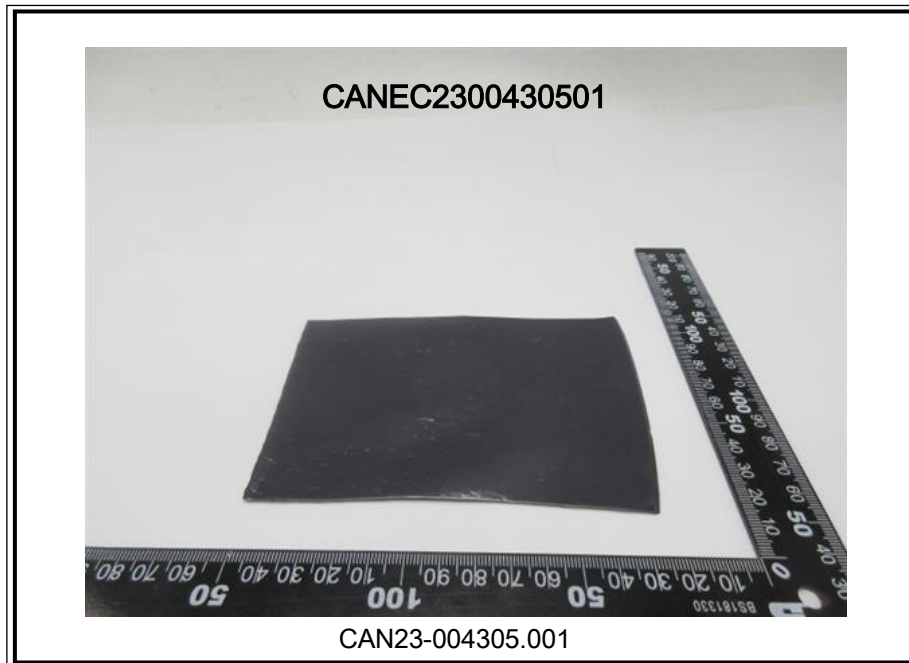
