Please could I advise you that part number 0110454 is not currently in stock.

As there are two versions of the MAX-550E, I would like to ensure that your team is ordering the correct version:

Part number 0110454 (R140P02-001) is a Max-550E for use with MaxBlend devices (MaxBlend 2, MaxBlend Lite and Blender Buddy 2). It is supplied complete with a special flow diverter which is narrower in diameter and has a small bleed hole (0120086). *I suspect this is the correct one as your order mentions Maxblend 2 on it.*

Part number 0110452 (R140P02) is a Max-550E for use with MaxO2 ME oxygen monitors. It is supplied complete with a standard 15mm I.D. flow diverter (0120094).
