INTERNATIONAL DISTRIBUTOR AGREEMENT AMENDMENT NUMBER TWO

This International Distributor Agreement Amendment Number Two (referred to hereinafter as "Amendment No. 2") is entered into and effective as of the 28th day of May, 2013 (hereinafter referred to as the "Amendment Effective Date") by and between Teledyne Analytical Instruments, a business unit of Teledyne Instruments, Inc.
