Thank you for your enquiry.

The TOF-3D Neuromuscular Transmission Monitor, part number 2510091 costs £1,400 each, plus £12 standard carriage, plus VAT.

There are a three different monitoring accessories available for the TOF 3D Neuromuscular Transmission Monitor to allow secure placement of the accelerometer for accurate twitch response monitoring:

- 2520111 Thumb Adapters (single use) @ £45.00+VAT / pack of 50
- 2520112 Eye Adapters (single use) @ £82.00+VAT / pack of 50
- 2520110 Hand Adapter (reusable) @ £38.50+VAT / each

Note: for hand placement, you can choose either the reusable hand adapter or the disposable thumb adapters, they are not used together. I have attached an Instruction Manual for reference, which illustrates the placement positions.
