This is not a major problem yet.

However ISO13485 expects all our suppliers to have ISO9000 or to have visited the manufacturers site and carried out a simple audit. This usually takes the form of a questionnaire asking if they have a quality system, keep records and employ post market surveillance.

If you have done this can you write to me stating you have and that you are satisfied.

This coupled with your ISO and quality system should be enough...

We already do this with some of our very small suppliers and so far have not had difficulties with our Notified body.
