We were waiting for the MaxO2+AE Oxygen Analyser (**0111262**) but have been advised they have been superseded, however we do have a back to back alternative which is the **0111261**.

This product **0111261** - MAXO2+ AE Oxygen Analyser is the exact same but an updated version with a longer length sensor cable which extends to 2.0metres whereas the older analyser (0111262) extended to 0.6metres.

We can give you this product at the same price as the 0111262 and there is also some stock available to order so there will be a lead time of 1-2 weeks as we are waiting for the T adaptors to arrive in stock.
