Hi Daniel,

Yes I can help you with this.

The MySign O is rechargeable and is available with or without the official power supply.

It operates for around 24 hours continuously before requiring recharging. In practice, this means you would likely have to charge the MySign O every few days. It can be used in a patient application whilst on charge *but only if using the official power supply*, not when connected to any other USB power supply.

You can charge it with a standard USB power supply or PC but this must be disconnected before using in a patient application as they are not certified for medical use, unlike the official PSU.

Hi Dan,

I can't see any record of Viamed having supplied this device to you, but we do sell it. If you have a serial number for the monitor itself, I can double check that for you.

What you have there is an Envitec MySign O with a OOM111 oxygen sensor, which is the correct sensor for the device.

I think the confusion came from your initial enquiry which stated that you have a *MAXO2 ME* oxygen monitor causing problems; Viamed did supply MAXO2 ME to the Trust but they are entirely different devices from different manufacturers.

For this device (MySign O), you need the following sensor:

- 0110560 - Oxygen sensor OOM111 @ £72.00+VAT
- Carriage: FOC

I have attached a copy of the user manual for reference. I should just point out first to look at the section on calibration, which advises that the device be calibrated before each measurement or once per day; if you have done that and it still doesn't read correctly, then the sensor will need replacing.

I hope this helps.

Hi Dan,

Well this threw me a bit: the OOA111 is an Envitec / Honeywell sensor that is designed for an Envitec MySign O monitor, it's not listed as compatible with the Maxtec MaxO2 ME, which might be part of the problem.

If you are using the OOM111 which has a 3.5mm connector, this would suggest that your device is the later MaxO2 ME with the blue housing, which takes a Max-550E sensor.

The MAX-550E sensor is chipped to allow the MaxO2 ME to identify it as the correct sensor and allow calibration, so I'm surprised that using another sensor worked at all. The correct sensor is available as follows:

- p/n 0110452 - Oxygen sensor MAX-550E @ £99.00+VAT
- Carriage FOC

Maxtec have 2 different devices branded as MaxO2 ME, but the older version takes a different sensor to the newer one. I have attached a document that will clarify this for you and show you the 2 sensor types:

- p/n 0110429 - Oxygen sensor MAX-250E @ £66.00+VAT
- p/n 0110452 - Oxygen sensor MAX-550E @ £99.00+VAT

Is the device being calibrated regularly as per the instructions? If the device has just undergone an air calibration but still reads low, the sensor could need replacing, but if the device has not been calibrated for some time, try that first.

Do you have a serial number for the sensor? If so, I can check how old it is and let you know if it's around the age that we would expect it to fail.
