Hi Mary,

I am unable to tell you exactly which sensor would be sent to you. It would depend upon other orders, so no picture is available.

The date code is April 2023 and there is not a definite expiry date for oxygen sensors. Your warranty would be 18 months from date of invoice.

This is our statement we use when asked about the expiry date:

The useful life of a sensor depends upon concentration of oxygen. If it is left inside the sealed gas barrier bag, its life expectancy should only deteriorate by 1/20th of its in air life per year. A shelf life of 1-3 years can be expected if sensors are stored correctly. The special gas barrier bag allows only a negligible amount of oxygen or moisture to pass through. It is not recommended that sensors are stored longer than absolutely necessary for warranty purposes. Sensors should retain 90% of their useful life after 24 months in the gas barrier bag.
