Thank you for the order but I think this may be incorrectly requesting the wrong sensor.

The sensor on your order is the Teledyne R-22A (the type that you had problems with) but Simon Brown advised me this morning that the R-22AVG sensor that we offered as an alternative and delivered 100-off this morning has tested well and that you would be moving over to these.
