Thank you very much for your email and message.

I believe that either our R-33VAN or R-33VAN(RP) would be a suitable replacement sensor, but I can not confirm this, as we have never tested it with a device.

The R-33VAN and R-33VAN(RP) are the same sensor, but the connector is wired the opposite way. They can be switched very easily.

If you have a spare device we can borrow to test a sensor then we could confirm this for you.

With regards to the R-33VAN-2, we can supply you at our trade price of GBP £65 each EXW. These sensors are assembled to order, the lead time is typically 1-2 weeks from receipt of order/payment.
