We recently spoke on the phone. I can confirm I have just processed your order on our system for 1x R-41V Oxygen Sensor (part number 0110041):



I have attached the technical specifications - our cross reference shows this sensor as being compatible with the CITREX H4, and also with the ITG M-03 Oxygen Sensor.

As mentioned on the phone, we only had 1 unit available in stock, which will now be sent to you. We are due more of these sensors in approximately 5-6 weeks.

The two other sensors we discussed were the Envitec OOM202-1 and OOMLF202-1 (lead free version).

Part number 0110585 (OOM202-1) is the exact same sensor as the R-41V, however comes with Envitec label, rather than Viamed. We do not have any Envitec labelled sensors in stock at the moment, but if you would prefer this version for any reason, please let us know.

Part number 0110806 is the lead free version of the sensor and the price is £55.00 each.
