Hi Jenny,

Following the delivery today of 150x R-22AVG, I just need to let you know that we now only have 1 forward-order left on the system from order ref 1458, which is due to ship on 4th July.

The manufacturing lead-time on batches is around 8 weeks, so we need to start looking at your requirements for August and beyond. Could I ask you to review this with a view to placing monthly call-offs?

As before, we can take this as a single order with multiple lines, each with separate delivery dates, and we will invoice them as we deliver with an incrementing suffix, i.e. order ref 1234/x. Carriage will be £12.00+VAT per shipment.
