- Functional Check Service and Certificate of Calibration The following are checked and assessed: Outputs settings, LEDs, membrane keys, intensity control, interface cushion and batteries. The outputs are tested to verify that they are within specification at the settings of: 30, 60, 90, 120, 150, 180 and 210 BPM.
   A functional test is carried out in conjunction with a foetal heart monitor and the unit is left on a soak test. Upon completion, a certificate of calibration is issued.
   The price for this is £60.00\* plus £12.00 return carriage (excluding VAT) part number 1480000.
- Repair Service This covers the labour on a cost of per hour basis to repair a
  returned faulty/damaged V1000. We will provide a quotation before any work is
  carried out.

Should you wish to utilise one of these services, please advise us of the serial number/s of the unit/s and we will provide you with a **returns** reference number. When returning units to us, please may we ask that you ensure that the units are returned with a certificate of

decontamination status. Please ensure that the item's packing is adequate and we advise that you use a traceable delivery service.
