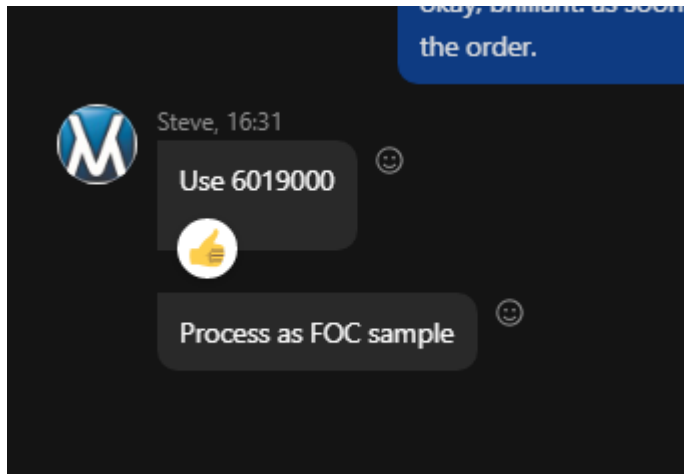

Ryan also offered an alternative strategy, which is to use special sampling lines that are porous and cause moisture to dissipate before it reaches the water trap, therefore supposedly helping the water trap last longer. These are called Versastream.

Kingsley, are they much more expensive than our regular Luer sampling lines? How often would we need to replace these – could they be reused for longer than we reuse the current ones?
