

Hi Steve,

Herewith the summary of what was discussed with R&D and product management:

It does not make sense to have a use-by time (considered here: time before the first use of the device AND lifetime of the sensor) since this depends predominantly on ambient conditions. The recommended ambient conditions for storage are stated on our (packaging) labels (+5° to +15°C). Therefore, we put the manufacturing date on the product label and refer to our warranty period starting with the manufacturing date.





Jessica already forwarded the current status of our standard labels to you. We never had any discussions with our Notified Body in this respect.

FYI: We are considering to amend the packaging label slightly (new symbol for "read instructions"; English text only). We are also going to introduce instructions for use (to be published on our website only), amongst others describing that the calibration of the sensor, required daily when used (active test by the respirator), ensures early detection of sensor consumption.

I suggest we change the Viamed labels accordingly.

Dear Eleonore

It looks like there should be a **USE BY** date on the oxygen sensors or the oxygen sensor packaging. Referring to the Medical Devices guidance document MEDDEV 2.2/3 rev.3:

"The use-by time relates to the period before the first use of the device. It does not relate to the number or period of subsequent uses (the lifetime of the device)."

We as Viamed have to do exactly the same as you the OEM. So what is your interpretation and that of your notified body?

The correct symbol to use is the sand timer, with date as YYYY-MM

If you decide to put a **use by** date, then I believe this should default to at least the warranty period, i.e. 15 months from date of manufacture. Of course if you have the shelf life tests to prove it is OK, from a realistic or marketing point of view we could of course state a longer period.

As we are own band labelling your sensors we need the Envitec interpretation of the following:

Use by dates, put into use by dates or install dates? The auditors say that we should have something.

We have said that this is confusing because you can have a use by date of say 1st September 2015, but the sensor could then be in use for say three years.

There doesn't appear to be any appropriate ISO symbol for install by, so perhaps we should both consider adding 'Install by' dates to the sensor packaging? This then would mean that the sensors have a shelf life, so we have them deem what is a safe or appropriate shelf life. Also would we need to qualify that by adding the protect from sunshine icon...
