Dear Andy

The number you have stated is R21746, I believe that you mean R217P46 (Viamed part number 0111278), which is the industrial version of the Maxtec MaxO2+A oxygen analyser. If you do require the industrial version, the delivery lead time will be about two weeks.

However, if you require the medical version P217P62 (Viamed part number 0111260), then these are available from stock.

I have attached datasheets for both units, they are effectively the same, but the medical verison includes a Tee piece and flow diverter. If you can confirm the version that you require I will ask the office to process a quotation for you.
