I can see that the serial number of your V1000 is **PR03507A14**.

You would need to send it to us for calibration. The price of a V1000 functional check service which includes the certificate of calibration is £60, plus £12 return carriage, plus VAT.

We are unable to issue an official quotation until the device has been received and checked over by the service team. After the device has been checked over, we would email a proforma invoice and not proceed until payment has been received.
