Thank you for your email. We would be happy to provide a V1000 on Sale or Return, for you to trial.

Please find attached our 'Sale or Return' Terms & Conditions Form, which will need to be completed by an authorised person within the Trust; it differs from Trust to Trust but this will usually be Procurement or any person responsible for organising loan equipment and/or trials.

Please can you return the form to me (a picture or scan attached to an email is fine but a fax is also acceptable), and can you also confirm a specific delivery address complete with department and contact details of the person that will accept responsibility for receiving and returning the goods, usually a senior member of Clinical Engineering.

The Sale or Return process allows you to trial a demo unit for a period of 30-days, covered under the Master Indemnity Agreement for the duration. We would ask that you attempt to keep to this time-frame and arrange for the device to be moved between key evaluators during that period if possible.
