

Dear John,
Malcolm has passed to me the first proof of the mailshot. You will notice
that we have made a few, minor alterations and additions and underlined
Train of Four and Post Tetanic Count for greater emphasis. Other points are
as follows;

- 1. We suggest a small package insert to inform users that alkaline batteries should be used for best results and, in the unlikely event of failure of the apparatus, that the leads should be first be checked for continuity before returning the unit for repair.
- 2. It may be useful (to counter the argument that ECG electrodes, and hence monitoring of neuromuscular blockade, entails undue expense) to add a paragraph to state that the least expensive pre-gelled ECG electrodes are perfectly adequate for this purpose. Do you market any electrodes which could be supplied at less cost than those used by most hospitals (20-25 pence each)? These could be ordered with the stimulator.
- 3. What are your plans for advertising in the journals?




