Thank you very much for your order. I am currently awaiting clarification regarding the DOC. Maxtec has a DOC for the standard MAX-14, but it does not specify the Fluke version. It may be that they consider the Fluke version to be covered by the MAX-14 DOC, or it could be that the Fluke version is not classified as a medical

device, as it is specifically used in test equipment that does not connect to a patient.

In the meantime, we have placed your order on hold until we receive a response from Maxtec.
