It seem the number \$279.16 is not correct yet.

- Difference of R-17V:  $(\$47.9 - \$32.5) \times 4\text{pcs} = \$61.6$

- Insurance fee: \$35.03

- Shipping charge: \$164.13

**TOTAL is \$260.76**

I suggest we will increase quantity sensor to balance \$260.76 as below quantity:

OOM-111:  $\$99 \times 2\text{pcs} = \$198$

R-22AVG:  $\$26.3 \times 1\text{pcs} = \$26.3$

R-17V:  $\$32.5 \times 1\text{pcs} = \$32.5$

Certificate of Origin fee:  $\$87.5 + \$3.96 = \$91.46$ .

So, we can balance  $\$260.76 = \$198 + \$26.3 + \$32.5 + \$3.96$ .

But I have an important question. If I pick up all part 1 & part 2 by DHL Express, do you have any trouble when making Certificate of Origin? If you have any trouble, you can arrange to ship Part 2 by UPS as usual. Certificate of Origin is very important with us, so I don't want there are any problems.
