Thank you very much for your email and I apologise for the late reply.

As I suspect you do not need any alarms for constant monitoring, but still require a medical accreditation and a replaceable sensor, the options are as follows:

- 0111260 MaxO2+A Oxygen analyser
- 0111261 MaxO2+AE Oxygen analyser

The only difference between the two analysers is that the first has an internal sensor and the second has a cable between the analyser and the sensor.

As registration is required in Italy for medical accredited equipment, it may be best that the quotation is done via our partners in Italy who supply Maxtec products, Medival.

If you are happy for me to pass your details on to them, they can issue you with a quotation.
