

Viamed Cot Lids Important User Information

Viamed has been supplying cot lids to the same standard design since 1987; with a user base that appears to be 100% satisfied and a record of zero customer complaints.

However, we recently had an incident where the baby kicked the cot lid off the bassinet.

As a result our concern has been the possibility that the cot lid would fall into the bassinet and potentially hurt the patient.

Investigation however has revealed:


- 1. No reported incidents of the cot lids falling into the bassinet.
- No reported incidents of babies causing damage to themselves kicking the cot lid off.
- 3. We are informed that babies are progressively becoming larger and stronger and possibly more able to dislodge the cot lid. It may therefore becoming appropriate to make a judgment as to the possibility of the cot lid being kicked off and finding another solution for the larger babies.
- 4. In the incident investigated the cot lid had been dislodged or kicked off the bassinet onto the floor.

As a result of our enquiries we believe his type of incident may increase in the future and we feel we should bring this to your attention.

There are two alternative solutions.

- 1. Re-design of the existing standard cot lid.
- 2. Limit the size of the babies who can be placed in a cot-lid environment.

Firstly we have taken the step of re-designing the cot-lid so that it is hooked over the cot-lid rim and cannot be dislodged. The clinical advice we have been given suggests that the babies will not hurt themselves trying to dislodge the new cot lids.

Existing Cot-lids

For existing users who believe that incidents of babies kicking off cot lids are a potential problem we offer a retrofit kit.

Essentially two acrylic strips are fitted to the vertical sides of the cot-lid.

The cot lid should be returned to Viamed.

Please pack carefully and insure against breakage.

We will carry out the upgrade and return the cot lid to you.
