Neither Collaborator will make any representation or do any act which may be taken to indicate that it has any right, title or interest in or to the ownership or use of any Background IP belonging to the other Collaborator except under the terms of this Collaboration Agreement. Each Collaborator hereby grants to the other Collaborator a licence to use its Background IP only for the purposes of the Project.

All intellectual property and know how generated in the course of the Project ("Arising IP") shall belong to the Trust. The Trust shall grant the University a licence to use Arising IP only for the Project and for academic and non-commercial research purposes and for evaluation, teaching and training purposes relating to the provision of care and treatment to NHS funded patients. All outputs of the

Project are available for internal teaching and research purposes by each or both of the Collaborators and in on-line research archives.

The University shall provide reports to the Trust for the Trust to fulfil its obligations in respect of reporting the full grant activity to the Funder in accordance with the Grant Agreement. These reports shall include but not be limited to financial reporting for all collaborating institutions on a 12 monthly basis of actual expenditure against the planned grant spend.

The Trust will forward to the University the total sum of £xx,xxx towards the cost of its contribution to the Project, subject always to receipt by the University of the funds from the Funder.
