Please could I advise you that the correct price of part number (R140P02) 0110452 - MAX-550E oxygen sensor **for use with MaxO2 ME Oxygen Monitor** is £112.10 each. The other price breaks are as follows:

1 = £ 112.10	2 = £ 109.40 each	3-10= £ 106.60 each	11 or more = £ 101.00 each

There are two versions of the MAX-550E.

I can see that part number 0110452 has been bought by your team in the past (October 2024).

0110452 (R140P02) is a Max-550E for use with MaxO2 ME oxygen monitors. It is supplied complete with a **standard 15mm I.D. flow diverter** (0120095).
