Thank you for your interest in the TOF 3D Neuromuscular Monitor. The TOF 3D Neuromuscular Transmission Monitor, part number 2510091, costs **£1,436.40 each**, plus £12 carriage, plus VAT.

There are now four different monitoring accessories available for the TOF 3D Neuromuscular Transmission Monitor to allow secure placement of the accelerometer for accurate twitch response monitoring:

- 2520111 - Thumb Adapters (single use): £46.20 + VAT / pack of 50
- 2520112 - Eye Adapters (single use): £84.20 + VAT / pack of 50
- 2520110 - Hand Adapter (reusable): £39.60 + VAT / each
- 2510106 - **NEW** MMG Sensor Hand Adapter (reusable): £875.00 + VAT / each

Please note: for hand placement, you can choose the reusable hand adapter, the disposable thumb adapters or the new MMG sensor hand adapter - they are not designed to be used together. I have attached an Instruction Manual for reference, which illustrates the placement positions. Please note this user manual is in the process of being updated by the manufacturer to include the MMG sensor hand adapter.



I have also attached leaflets for your information.

The device uses standard paediatric electrodes, which Viamed does not supply, but which are readily available through standard supply chain channels.

Instructions for use are supplied in accordance with the Medical Device Regulation, and the device is for use by suitably qualified personnel: specialists, anaesthetists and nurses with specialisation in anaesthesia care.

In addition, we can supply training materials for use by the Hospital Clinical Educator, these include: PowerPoint training presentation and a Windows based simulator which provides full operation simulation of the device. We also offer support to Clinical Educators. However, **we currently do not include on-site training**.
