We are very interested in selling your VM-2160 SMARTsat in Denmark.

I understand that your current distributor is GM Medical, which has been acquired by a large corporation in Denmark ½ years ago.

They will not be able to give your product the level of attention our team can, as their primary focus is on large equipment.

When we engage with a product, we prefer to have exclusivity—this would also be the case here.
