Thank you for your reply and for sending the photos. The label showing both versions is understandably unhelpful; however, from the sticker on the front I was able to identify the serial number and confirm that this is an AX300 Oxygen Analyser originally supplied by us in 2016.

Before I make a recommendation, could you please clarify what you need the device to do in your current setting? This will help us ensure we suggest the most appropriate and cost-effective solution. We suspect that the hypoxic alarm feature on the AX300 may not be necessary for your application, and that another device could be a better fit—but we'd like to confirm your exact requirements first.

Once we have this information, we can advise on the best option.
