Thank you for your enquiry.

We do provide a calibration service for the V1000.

If you would like to send us the device, (serial number PR02894A12?) I would issue you with a returns reference number to quote on any paperwork. We would also ask for a certificate of decontamination. (This can just be something stating whether the item **has or has not been fully decontaminated**, that would be acceptable).

The price is \$63.40, plus return carriage. There would be a cost for any parts that may need to be replaced/repaired.

Upon receipt of the device, we would issue a proforma invoice and not proceed until payment is received.
