We used to purchase the original Nomoline directly from Masimo, but we were only allowed to supply them with our equipment, which at that time we used their ISA sensors. We no longer supply that product and therefore have no access to the accessories. I can't suggest anyone to contact, as Masimo have tried to channel all consumables through their own offices.

In regards to the O2 sensors, we have our own version which is manufactured for us by Honeywell (Envitec) in Germany:
