I agree that some units are still with your team, so these will need servicing under the existing quotation QVM154936.

Before I issue a quotation, I need to mention that whatever units are outstanding need to be sent to us for servicing by the end of March 2026. Also we would need any service exchange units to be returned to us for their service before we can commence the new service agreement.

The prices for the new service quote for the next 12 months need to be agreed with our commercial director, so I am unable to issue a quotation just yet.

New hoses are required every five years, so this will be included on the quotation.
