Thank you for your message. I'm responding on behalf of my colleague, Kate.

Where a sensor is classified as a component intended for integration into other equipment, rather than as a stand-alone end-user device – it is not necessarily required to carry CE marking. While some sensor manufacturers still choose to apply CE marking or provide a Declaration of Conformity, this depends on how the product is positioned in the market.

In this case, City Technology (Honeywell) have designated the MND1S and MNO1B sensors as components, and as such, they are not CE marked and do not come with a Declaration of Conformity.

Please let us know if you require any additional documentation, such as technical datasheets or RoHS/REACH declarations.
