Your 2026/27 charges

Like all water retailers, we review our charges every year. As a result, you will soon see some changes to the charges reflected in your bills. These changes will apply to all of your premises in England that we provide water and/or waste water services for and will come into effect from **1 April 2026**.

This communication explains what's changing, why these changes are happening, and how this may affect your bills.

Wholesale and retail charges

Your water bill is made up of two elements; wholesale charges set by your regional water company, which are the same for all water retailers and help to manage and maintain the water and sewerage infrastructure used to supply your services, and a retail charge which is a small uplift to cover the services we provide as your water retailer like billing, meter reading, account management and customer support.

Wholesale price change percentages for your region are listed in the tables on the next page. We recognise these changes come at a time when many businesses are already facing increased cost pressures. We're committed to doing everything we can to help our customers to minimise the impact and we've included information on the ways we can provide support on the last page of this letter.

Our retail charges are based on the published 2026/27 wholesalers' charges and Ofwat's previously published Retail Exit Code price controls. From **1 April 2026**, your charges will be adjusted in line with Ofwat's regulatory price controls which vary by region and service.
