- 2520111 - Thumb Adapters (single use): £46.20 + VAT / pack of 50
- 2520112 - Eye Adapters (single use): £84.20 + VAT / pack of 50
- 2520110 - Hand Adapter (reusable): £39.60 + VAT / each
- 2510106 - **NEW** MMG Sensor Hand Adapter (reusable): £875.00 + VAT / each

Please note: for hand placement, you can choose the reusable hand adapter, the disposable thumb adapters or the new MMG sensor hand adapter - they are not designed to be used together.
