Thank you for your email.

I am sorry to advise that this product has now been discontinued by Honeywell Medical and is no longer available to purchase.

We appreciate this will be disappointing news, especially for customers who have been using the MySign O for some time. Honeywell have advised that the decision was made due to spiralling costs and availability issues with some of the components required to manufacture the device. Unfortunately, this has made continued production no longer viable.

An alternative is part number 0111263 - MaxO2 ME oxygen monitor. Please see leaflet attached. The price is €521.60 each EXW. This monitor is currently in stock.
