The packing must be of a sturdy export quality of a commercial standard that will provide adequate protection of the goods for carriage by AIR, SEA, and/or ROAD to final destinations worldwide, including remote locations under adverse climatic and storage conditions and high humidity.

It is the responsibility of the vendor to provide complete packing as required for transportation. Hazardous (dangerous) and temperature restricted goods must be packed, handled and documented according to current legislation and the instructions in the PO.

Cartons to be properly lashed/secured on heat-treated pallets and if necessary shrink foiled and strapped with 2 plastic strips on each side with hardboard on top to avoid cartons being damaged by the strips.

TEMPERATURE LOGGERS:
In case shipment contains products with a temperature limit, at least two data loggers should be added per shipment.

Preferably Tempmate® S1 module must be used. In case another type/brand of temperature logger is considered, please take into account the following specifications:

- A certificate of calibration/validation must be available

- Temperature accuracy of ±0,5°C
- Memory capacity of at least 16.000 readings (16K)
- A logging interval of 1 minute to 30 minutes
- A delay start of 5 seconds to 10 days
- Ability to set high and low alarm limits
- Capability of producing graphs, numerical data and summary reports
- A direct USB 2.0, A-Type plug
- PC requirements: at least be usable on Windows 7 or higher and Adobe Reader 9.0 or higher
- Battery life of at least 12 months
