Last week we were advised that the Viamed CE certification for our oxygen sensors manufactured by Envitec is no longer valid.

In response to this the sensors will now be labelled and covered by certification issued by CE 0123 (TÜV SÜD) instead of CE 0086 (British Standards Institute). The sensor deliveries will not be affected.

In addition, the sensors will be labelled with the 'factory' symbol followed by the text: Envitec-Wismar GmbH, this is to clearly show that the sensors are manufactured by Envitec. The sensors will still be Viamed branded and labelled with our contact details. The sensors will state of part numbers (REF) and model numbers.
