SCOPE

This procedure is established to describe the system used within the company for the control of Software Validation. It is used in conjunction with the individual sub procedures, which show the relevant information necessary.

RESPONSIBILITIES

It is the responsibility of the Managing Director, to ensure that the contents of this procedure, and related procedures, are adhered to.

PROCEDURE

Third party software used to maintain the QMS system shall be validated against its required outputs before it is used unless it has been certified for use with ISO 9001 ISO 13485 QMS systems.

All new Intrastats processes shall be validated against required inputs and outputs as of 04/09/2018.

Existing processes have been in use before the introduction of 9001:2015. and have been classed as validated through use.

Accounts package is externally Audited via Accountants to produce year end accounts.

Accounts are cross matched to Banks, and Vat returns Etc..

Backup Software

Rolling task : 454, to Compare Turnover screen of the Live Server and VMserver8, indicates the backup system has updated correctly.

Intrastats – Accounts package Imports,

Where data is imported a Rolling Task 459, Compares turnover from Opera report screen to intrastats report screen. As Intrastats works out the turnover via each individual credit / Invoice, and is compared to the Overall figure within Opera. The data import routines are regularly Validated.

Intrastats, general.

Depending on the severity of the operation several rolling tasks have been identified to validate functions of the intrastats system.
