Hi Simon,

The order that we have (PO20000518) is still for 250 x MX300 as you hadn't yet fully confirmed that you would take the MAXO2ME in place of the MX300 with a revised order, but I will take this email as confirmation of an order amendment and will have the office amend and re-send the proforma accordingly.

Just to be clear though, at the moment, we are not taking large orders without a cleared payment upfront as we have seen a number of large orders get dropped after we have committed to manufacturing the stock. I hope you are both well. I have an update for you: the 100x MX300 oxygen monitors shipped from Teledyne on Friday and we are expecting them imminently, possibly tomorrow.

Please can I ask that you now make payment totaling £48,3360.00 (£40,300.00+VAT) against proforma MVM123277 to allow us to ship these to you as soon as they arrive?

The remaining 250 units can be fulfilled with Maxtec MAXO2ME devices, the delivery schedule would be to start shipping to us 8th June and complete the order in full by the 26th June. However, please be advised that manufacturing on those will not proceed until you confirm that you want to accept the MAXO2ME as an alternative and payment is made against a revised proforma invoice.

If you want to secure the manufacturing for 250x MAXO2ME, please advise in writing asap so that a received proforma can be sent to you, thanks.
