Thank you for your email.

Under normal circumstances, we would recommend our alternative sensor, the R-48V, as it is more economical. Unfortunately we have no stock of the R-48V and no confirmed date as to when we can obtain anymore.

I have approximately 50x MAX-3 available from stock, so we could ship the 43 urgent pieces. I have no confirmed date on the remaining balance, but I can confirm we are receiving regular orders from Maxtec.
