Please note that when I first discussed with Duncan we had spare production capacity, but this was weeks ago. Generally the worldwide production is backlogged, many companies are quoting >September/October, even for medical sensors which are the priority.

At the moment we could start to supply sensors Week 31 (perhaps some earlier). I would urge you to please confirm your current requirements (and short term future) ASAP as the large OEM's are taking up all the spare capacity. We are currently working on backlog production for the next 6+ months.
